

## **PITTSBURGH PENGUINS AND BURNS SCALO HOME PROTECTION PROMOTION OFFICIAL RULES**

1. All individuals must be twenty-one (21) years of age or older and a legal resident of Pennsylvania to participate in the Burns Scalo Home Protection promotion. Void in all other jurisdictions and where prohibited by law.

2. Employees, contractors, directors and officers of Burns Scalo or the Scalo Companies (“Burns Scalo”) and Pittsburgh Penguins LP (“Penguins”), and members of the immediate family (spouse, parent, child, sibling, and their respective spouses) and household members of each such employee are not eligible to participate.

3. By participating, entrants agree to these Official Rules and decisions of Burns Scalo and Penguins, which are final and binding in all matters relating to this promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

4. The promotion begins on September 21, 2023 at 12:00:01 a.m. Eastern Time (“ET”) and ends on November 30, 2023 at 11:59:59 p.m. ET. Throughout the promotional period, Burns Scalo will randomly select one (1) winner from among all eligible customers plus mail-in entries received during the promotional period. An entrant is not a winner of any prize, even if the drawing should so indicate, unless and until entrant’s eligibility and compliance with the official rules have been verified and entrant has been notified that verification is complete. The potential winner will be notified by either email or phone using the information provided during entry into promotion or from records provided to Burns Scalo by entrant. If a potential winner cannot be reached (regardless of reason), or is disqualified for any reason, the potential winner will forfeit the prize and Burns Scalo will award the prize to an alternate winner selected at random from the remaining entries. Upon disqualification, no further compensation will be given. Failure to comply with any term or condition in these rules may result in disqualification at Burn Scalo’s sole discretion. One (1) entry per person permitted.

All eligible entries using this entry method – i.e., the entry method in Paragraph 5(b) of these Official Rules – will receive two (2) lower bowl seats in either sections 117,118,119 or 106,107,108. An autographed jersey signed by a member of the Pittsburgh Penguins, and a \$500 Visa Gift Card (‘Grand Prize’). Penguins Regular Season home game tickets to a game will be selected by Burns & Scalo, . Additional purchases do not count toward additional entries.
